### WATER TREATMENT OPERATOR

**Water Treatment Operator Salary Range: \$72,576-\$96,768 per year**

**Senior Operator Salary Range: \$81,052-\$108,070 per year**

#### Open Until Filled

Calleguas Municipal Water District (CMWD) in Thousand Oaks, California has one full-time opening for a Water Treatment Operator or Water Distribution Operator, depending on qualifications. CMWD is a wholesale water agency that services most of Ventura County and is a member agency of the Metropolitan Water District of Southern California (MWD). Water is delivered into the Calleguas service area through a system connection with Metropolitan. The majority of Calleguas' water supply is treated at Metropolitan's Jensen Treatment Facility in Granada Hills. The District then conveys the high quality drinking water through 150 miles of pipelines, reservoirs and pump stations to local cities and water agencies for delivery to consumers. In order provide customers with water during outages of imported supplies, the District also owns and operates a lake with a surface water treatment plant and an aquifer storage and recovery facility with 18 wells.

#### Special Requirements

- Must possess at least a current a California Department of Health Services Water Treatment Operator Grade 2 (must be able to obtain Water Treatment Operator Grade 3 within 18 months of hire) and Water Distribution Operator Grade 3 certificates to qualify for a Water Treatment Operator. Must possess a California Department of Health Services Water Treatment Operator Grade 3 and Water Distribution Operator Grade 4 certificates to qualify for Senior Operator.
- Requires is a strong working knowledge of the operation of water distribution systems, the treatment of water and the ability to exercise good judgment in pressure situations.
- Possession of an appropriate California operator's license issued by the State Department of Motor Vehicles. Possession and proof of a good driving record as evidenced by freedom from multiple or serious traffic violations.
- Must be able to handle and use typical cleaning materials and analytical chemicals used in water quality testing. Must be able to work around chlorine and other chemicals used in treatment of water which are classified by Title 8, California Occupational Safety and Health Regulations, Code Section 339 as extremely hazardous materials and copper sulfate which is a toxic material.
- Must be able to work rotating shifts of eight or twelve hours and be able to respond to a request to work on short notice.
- Must agree, in writing, to have an "on-the-job" paid meal period since the nature of the employee's work will prevent the employee from being relieved of duty.

- Ability to wear Self Contained Breathing Apparatus gear and respirator.
